

CAMPAIGN OVERVIEW

GoldPass® AUD 10,000 Giveaways is designed to encourage use by delegates of The Perth Mint's GoldPass® App at the Diggers & Dealers Mining Forum, Kalgoorlie, Western Australia ("**Forum**"), Monday 5 until Wednesday 7 August 2019.

To enter Giveaways delegates are required to download the GoldPass® App from the Apple App Store or Google Play. The Perth Mint will distribute 1,200 unique QR coded flyers at the Forum, each linked to a prize. Each prize consists of a portion of a troy ounce of gold equivalent to a monetary amount ranging from AUD 2.05 to AUD 501.37. Each prize will automatically credit to the corresponding GoldPass® account.

Giveaways will run from Monday 5 August 7:30am until Wednesday 14 August 2019 11:59pm AWST.

 - d. have attained the age of 18 years; and
 - e. be able to download the GoldPass® App.

The Prizes are referenced to the AUD gold price per troy ounce, using the benchmark reference rate, taken from the LBMA AM Gold Price of AUD2,054.78 on the 29 July 2019 (published on the ICE website <https://www.theice.com/marketdata/reports/178> and by Thomson Reuters with quote reference RIC <XAUFIXAMAUD=>). However the Prizes may be worth less or more at the time of the Giveaways, depending on subsequent movement in the market price of gold.
14. Each QR Code connects to one (1) Prize.
15. There is a maximum of 1,200 Prizes to be won, comprising a total of AUD 10,170.03.
