TERMS AND CONDITIONS – BLACK FRIDAY PROMOTION 2025

1. APPLICATION

- (a) These terms and conditions ("**Terms**") apply to purchases made by customers ("**Customer**") under the 'Black Friday Promotion' ("**Promotion**").
- (b) The Promotion is provided by Gold Corporation (ABN 98 838 298 431) of 310 Hay Street, East Perth, WA 6004, a statutory authority of the Government of Western Australia established under the *Gold Corporation Act 1987*, trading as "The Perth Mint" ("**The Perth Mint**").
- (c) A Purchase made under this Promotion is deemed acceptance of these Terms.

2. **DEFINITIONS**

For the purposes of these Terms:

Discount means a reduction of up to 30% off the original retail price of an Eligible Item during the Promotion Period, as set out in **clause 3(b)**.

Eligible Item means a selected range of in-stock numismatic coins, jewellery, and giftware available for Purchase during the Promotion Period. Eligible Items do not include loose diamonds, bullion products, gift cards, made-to-order items, or any other excluded products as determined by The Perth Mint in its sole discretion.

Promotion Period has the meaning given in clause 3(a).

Purchase means making full and final payment for an Eligible Item.

- (b) Eligible Items may be purchased during the Promotion Period via the following methods:

 - (iii) in-store at The Perth Mint Shop, located at 310 Hay Street, East Perth WA 6004.
- (c) All Purchases made during the Promotion Period are subject to The Perth Mint's refund policy available in the 'Terms and Conditions for purchasing collector coins, gifts, diamonds and jewellery' accessed at T&Cs | Buying coins, gifts, diamonds, jewellery, and other relevant terms on The Perth Mint's Website.
- (d) If a Customer's request to return Eligible Items purchased during the Promotion Period is approved by The Perth Mint, the Customer will receive a refund which will reflect the discounted price and not the original full price. The Customer can still participate in the Promotion if the Promotion is still ongoing. However, the Customer will not be able to participate in the Promotion outside the Promotion Period.

- (a) The Perth Mint reserves the right to make the changes to the Terms.
- (b) In the event of a change to the Terms, The Perth Mint will publish the updated Terms on the Website, which shall take effect from the time of publication.

5. LIMITATION OF LIABILITY

- (a) The maximum liability of The Perth Mint to the Customer at any time, provided only to the extent that The Perth Mint is at fault, is limited to the price the Customer paid for the Purchase.
- (b) Under no circumstances will The Perth Mint be liable to the Customer for any indirect, incidental, consequential, special, punitive or exemplary damages, including without limitation damages for loss of revenue or loss of profits, loss of reputation or loss of goodwill, or delay in delivery of the order, or any increased costs incurred by the Customer arising from any provision of these Terms even if The Perth Mint has been advised of the possibility of such liability or foresaw or could have foreseen such liability, and notwithstanding whether such liability arises in contract, tort, equity or otherwise.

6. PRIVACY

- (a) Any personal information submitted by the Customer to The Perth Mint is subject to and will be handled in accordance with The Perth Mint's Privacy Policy set out at perthmint.com/privacy-policy/.
- (b) The Customer agrees that, by purchasing any Eligible Item pursuant to these Terms or communicating with The Perth Mint, the Customer has read the Privacy Policy, understood its contents and consent to its requirements.

7. SEVERABILITY AND JURISDICTION

- (a) If any provision of these Terms becomes invalid by law, regulation or proceeding, all other provisions remain in full force and effect.
- (b) These Terms constitute the entire agreement between the Customer and The Perth Mint with respect to the transaction contemplated in these Terms and supersedes and extinguishes all prior oral agreements and understandings between the Customer and The Perth Mint with respect to the transaction.
- (c) These Terms are governed by the laws of the State of Western Australia and applicable laws of the Commonwealth of Australia and the Customer and The Perth Mint submit to the nonexclusive jurisdiction of the courts of that State and courts which hear appeals in those courts.

8. WAIVERS AND REMEDIES CUMULATIVE

- (a) No failure to exercise and no delay in exercising any right power or remedy under these Terms shall operate as a waiver, nor shall any single or partial exercise of any right, power or remedy preclude any other or further exercise of that or any other right, power or remedy.
- (b) The rights, powers and remedies provided to The Perth Mint under these Terms are cumulative and are not exclusive of any rights, powers or remedies provided by law.
