

THE COLLECTOR VAULT – VIP SURPRISE GIFT (OCTOBER 2025) TERMS AND CONDITIONS

1. APPLICATION

- (a) These terms and conditions ("Terms") apply to eligible members ("Member", "you", "your") who participate in The Collector Vault 2025 Special Edition Medallion Promotion ("Promotion").
- (b) The Promotion is provided by Gold Corporation (ABN 98 838 298 431) of 310 Hay Street, East Perth, WA 6004, a statutory authority of the Government of Western Australia established under the *Gold Corporation Act 1987*, trading as The Perth Mint ("The Perth Mint", "we", "us", "our").
- (c) These Terms are to be read in conjunction with The Collector Vault Terms and Conditions ("Collector Vault Terms") (available at https://www.perthmint.com/terms-and-conditions/collector-vip/) and The Perth Mint Privacy Policy (available at https://www.perthmint.com/privacy-policy/).
- (d) Capitalised terms not otherwise defined in these Terms have the meaning given to them in the Collector Vault Terms.

2. PROMOTION AND GIFT

- (a) Under the Promotion, eligible Members may redeem one complimentary Collector Vault 2025 Special Edition Medallion ("**Gift**").
- (b) The Gift is a gold-plated aluminium-bronze, double-sided medallion featuring:
 - (i) the Collector Vault VIP Program logo and the year date 2025; and
 - (ii) The Perth Mint swan surrounded by the engraved words "The Perth Mint Australia".
- (c) The Gift is provided free of charge and is non-transferable, not exchangeable, and not redeemable for cash, credit or any other item.
- (d) The Gift is offered in limited quantities and will be distributed on a first-come, first-served basis while stocks last. The Perth Mint does not guarantee that every eligible Member will receive a Gift.

3. ELIGIBILITY

- (a) Eligibility to participate in the Promotion is limited to Members of the Collector Vault VIP Program who hold a current VIP Status Tier of Silver, Gold, Platinum, or Platinum Plus at any time between Tuesday, 28 October 2025 and Monday, 3 November 2025.
- (b) Members must be logged into their Eligible Account when redeeming the Gift.
- (c) Members who have opted out of receiving promotional emails from The Perth Mint may not receive direct email notifications for this Promotion. However, if otherwise eligible, they may still redeem the Gift by logging into their account on The Perth Mint website during the applicable period.
- (d) Staff Members participating in the VIP Program are eligible to redeem the Gift only in accordance with these Terms and the Collector Vault Terms.

4. PROMOTIONAL PERIOD

(a) The Promotional Period means the period commencing on Tuesday, 28 October 2025, and ending on Sunday, 21 December 2025, or earlier if Gift stock is exhausted.



(b) The Perth Mint may, at its discretion, shorten, extend, suspend or cancel the Promotional Period without prior notice, including where stock levels are depleted or operational needs require it.

5. REDEMPTION PROCESS

- (a) Eligible Members will receive notification of the Promotion by email and/or through a promotional banner displayed within their November 2025 pre-release communication.
- (b) To redeem the Gift, a Member must:
 - (i) log into their Eligible Account on The Perth Mint website during the Promotional Period;
 - (ii) manually add the Gift to their online cart (the Gift will not be automatically added); and
 - (iii) complete the checkout process in conjunction with a purchase.
- (c) A purchase is required for the checkout process to validate redemption of the Gift. There is no minimum spend requirement and no specific product needs to be purchased.
- (d) Each eligible Member may redeem one Gift only for the duration of the Promotion. Creating multiple memberships or placing multiple orders will not entitle the Member to more than one Gift.
- (e) Standard delivery conditions apply. Members in the Gold, Platinum, and Platinum Plus tiers will receive free shipping in accordance with their VIP benefits. Members in the Silver tier are required to pay standard shipping fees unless their order qualifies for free shipping under their membership entitlements.
- (f) If a Member fails to manually add the Gift to their cart or fails to complete checkout before the end of the Promotional Period, the Gift will be forfeited.

6. STOCK, SUBSTITUTIONS AND ERRORS

- (a) Gifts are subject to limited availability and will be distributed on a first-come, first-served basis.
- (b) The Perth Mint does not guarantee that every eligible Member will receive a Gift.
- (c) If the Gift becomes unavailable, The Perth Mint may provide a substitute item of equal or greater value at its discretion.
- (d) The Perth Mint accepts no responsibility for late, lost, incomplete, or misdirected redemption attempts, nor for any technical malfunctions, website errors or system interruptions that affect a Member's ability to redeem the Gift.

7. RETURNS AND EXCHANGES

The Gift cannot be returned, exchanged or refunded.

8. MEMBER CONDUCT

- (a) Members must comply with these Terms, the Collector Vault Terms, and any applicable customer code of conduct.
- (b) The Perth Mint reserves the right to refuse, cancel or disqualify any redemption or participation where it reasonably suspects breach, misuse, fraud or other improper conduct.

9. CHANGES TO THESE TERMS

The Perth Mint may update or amend these Terms at any time. Any changes will be published on The Perth Mint website and will take effect upon publication. Continued participation in the Promotion after publication constitutes acceptance of the updated Terms.



10. LIMITATION OF LIABILITY

- (a) To the extent permitted by law, The Perth Mint makes no representations or warranties regarding the Gift, including its quality, fitness for purpose or merchantability.
- (b) Where liability cannot be excluded by law, The Perth Mint's liability is limited to the re-supply of the Gift or a comparable item of equivalent value.
- (c) The Perth Mint is not liable for any indirect, incidental, consequential, special, punitive or exemplary losses or damages, including without limitation any loss of revenue, profit, goodwill or reputation, arising in connection with this Promotion.

11. PRIVACY

- (a) Any personal information collected in connection with the Promotion will be handled in accordance with The Perth Mint's Privacy Policy.
- (b) By participating in the Promotion, Members consent to The Perth Mint collecting, using and disclosing their personal information for purposes related to administering the Promotion and for other purposes set out in the Privacy Policy.

12. SEVERABILITY AND ENTIRE AGREEMENT

- (a) If any provision of these Terms is found to be invalid or unenforceable, the remaining provisions will continue in full force and effect.
- (b) These Terms must be read together with the Collector Vault Terms. Together, they constitute the entire agreement between the parties regarding participation in the Promotion and supersede all prior communications and understandings relating to it.

13. WAIVERS AND REMEDIES CUMULATIVE

- (a) No failure or delay by The Perth Mint in exercising any right, power or remedy under these Terms operates as a waiver.
- (b) The rights, powers and remedies provided under these Terms are cumulative and in addition to those provided by law.

14. GOVERNING LAW AND JURISDICTION

These Terms are governed by the laws of Western Australia and the applicable laws of the Commonwealth of Australia. The parties submit to the non-exclusive jurisdiction of the courts of Western Australia and any courts entitled to hear appeals from those courts.
