# IDENTIFICATION REQUIREMENTS

## ID requirements for Bullion or Nugget Buybacks

In accordance with requirements under the Anti-Money Laundering and Counter Terrorism Financing Act 2006 (AML/CTF Act), you must present **one primary document from the list below containing your full name, date of birth and current residential address. If it does not contain all of the required information, you must also supply secondary document(s) that contains the missing information.**

### **Primary Identification Documents:**

- Driver's Licence (Australian or foreign, containing a photograph and signature)
- Passport (Australian or foreign, containing a photograph and signature)
- National Identity Card (Foreign, containing a photograph and signature)
- Card (Issued by Australian State or Territory, containing photograph, giving proof of age)
- Birth Certificate (Australian or foreign)
- Citizenship Certificate (Australian or foreign)
- Pension Card (Australian, issued by Centrelink)

### **Secondary Identification Documents with name of Individual and physically linked to current Residential Address (Type**

#### **1 – Single Document Acceptable):**

- Utility Bill (Water, Gas, Electricity, Fixed Telephone Home line) less than 3 months old recording provision of services to Individual
- Shire/Council Rates notice less than 3 months old recording services to the Individual
- Official Letter/Statement issued by a Commonwealth, State or Territory Agency issued within the preceding twelve months where applicable recording financial benefits to individual, or from ATO recording debts payable to/by individual and by/to ATO or Local Government/Utilities provider recording provision of services to individual
- Under 18's letter from a School Principal, in relation to a person under the age of 18, issued within the preceding three months recording the period of time the individual attended that school

### **Secondary Identification Documents with Residential Address (Type 2 – Documents less than 3 months old, acceptable as one of two or more):**

- Bank Statement – with sighting of corresponding debit/credit card
- Employment payslip(s) with address
- Insurance bill – home, car, etc
- Internet provider, Foxtel, Austar bill
- Medical Statement – radiology, pathology, etc

### **Notes**

- All ID documents must be current, except passports which must be less than 2 years expired. All customers undergoing face to face identification verification must sign a declaration acknowledging that all information they have provided to The Perth Mint Shop is current and correct
- Translations: Any documents in a language other than English must be accompanied by an English translation prepared by an accredited translator

## ID requirements for Jewellery Buybacks

Identification documents must provide your date of birth, full name, signature, and current residential address. You must bring the following documents to us with your gold jewellery:

- A current photographic driver's licence, passport or Proof of Age Card
- A utility bill (electricity, water or gas) issued less than three months ago with current residential address displayed

If correct identification documents are not provided, we are unable to proceed with the jewellery buyback. Other forms of identification may be acceptable but must be confirmed by a staff member at The Perth Mint Shop and in compliance with the Pawnbrokers and Second-Hand Dealers Regulations 1994 (WA).
